| Level IV | Practicum in Marketing OSSEID: 12954G1.0044 Grades: 12 Prerequisite: Advertising; Fashion Marketing, Social Media Marketing, Sports and Entertainment Marketing Credit: 1 | Practicum in Marketing is a series of dynamic activities that focus on the customer to generate a profitable exchange. Course Standards

Principles of Business, Marketing, and Marketing

- 1. **General requirements.** This course is recommended for students in Grades 9-12. Students shall be awarded one credit for successful completion of this course.
- 2. Introduction.
 - A. Career and technical education instruction provides content aligned with challenging academic standards and relevant technical knowledge and skills for students to further their education and succeed in current or emerging professions.
 - B. The Business Management and Administration Career Cluster focuses on careers in planning, organizing, directing, and evaluating business functions essential to efficient and productive business operations.
 - C. In Principles of Business, Marketing, and Marketing, students gain knowledge and skills in economies and private enterprise systems, the impact of global business, the marketing of goods and services, advertising, and product pricing. Students analyze the sales process and financial management principles. This course allows students to reinforce, apply, and transfer academic knowledge and skills to a variety of interesting and relevant activities, problems, and settings in business, marketing, and Marketing.
 - D. Students will participate in at least two Career Exploration Work-Based Learning experiences in this course, which might include guest speakers and workplace tours relevant to the program of study.
 - E. Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations.

3. Knowledge and skills.

- A. The student demonstrates professional standards/employability skills required by business and industry. The student is expected to:
 - 1. communicate effectively with others using oral and written skills;
 - 2. demonstrate collaboration skills through teamwork;
 - 3. demonstrate professionalism by conducting oneself in a manner appropriate for the profession and workplace;
 - 4. demonstrate a positive, productive work ethic by performing assigned tasks as directed;
 - 5. comply with all applicable rules, laws, and regulations; and
 - 6. demonstrate time-management skills by prioritizing tasks, following schedules, and tending to goal-relevant activities in a way that uses time wisely and optimizes efficiency and results.
- B. The student describes the characteristics of a business. The student is expected to:
 - 1. explain the principles of supply and demand;
 - 2. differentiate between goods and services;
 - 3. identify the types of business;
 - 4. compare the different forms of ownership;
 - 5. examine the organizational structure and functions of business;



- 6. interpret the nature of balance sheets and income statements; and
- 7. identify business cycles.
- C. The student defines ethics in business. The student is expected to:
 - 1. distinguish between ethical and unethical business practices; and
 - 2. contrast ethical, moral, and legal choices that relate to the decision-making process in business situations.
- D. The student differentiates between the types of economic systems with an emphasis on the private enterprise system and the U.S. economy. The student is expected to:
 - 1. compare and contrast the types of economic systems, including traditional, centrally planned, market, and mixed economies;
 - 2. summarize the characteristics of the private enterprise system; and
 - 3. identify factors affecting business profits, revenues, and expenses.
- E. The student relates to the impact of international business on the U.S. economy. The student is expected to:
 - 1. explain the role of business in a global society;
 - 2. compare domestic and world trade; and
 - 3. explain the impact of imports and exports on the U.S. economy.
- F. The student identifies the role and impact of government, the legal system, and organized labor in business. The student is expected to:
 - 1. differentiate among the roles of government in business;
 - 2. describe types of activities performed by governments in business;
 - 3. ascertain the role of the legal system in business; and
 - 4. explain the role of organized labor in society.

G. The student classifies types of businesses that market goods and services. The student is expected to:

- 1. explain the importance of different marketing strategies for goods versus services;
- 2. define business and industry terms such as producers, raw-goods producers, manufacturers, builders, trade industries, retailers, wholesalers, and service businesses;
- 3. identify types of retailers;
- 4. explain the role of retailers in a private enterprise system;
- 5. identify examples of wholesalers; and
- 6. describe the role of wholesalers in a private enterprise system.

H. The student analyzes cost and profit relationships in Marketing. The student is expected to:

- 1. explain the concept of productivity;
- 2. analyze the impact of specialization and division of labor on productivity; and
- 3. explain the concept of organized labor and business.

I. The student understands the fundamental principles of money. The student is expected to:

- 1. evaluate forms of financial exchange, including cash, credit, debit, and electronic funds transfer;
- 2. identify types of currency, including paper money, coins, banknotes, government bonds, and treasury notes;
- 3. list functions of money such as medium of exchange, unit of measure, and store of value;
- 4. summarize the purposes and importance of credit; and
- 5. explain legal responsibilities associated with financial exchanges.



J. The student demonstrates an understanding of personal financial management. The student is expected to:

- 1. explain the importance of providing accurate information;
- 2. calculate gross and net pay;
- 3. simulate opening and maintaining various types of bank accounts;
- 4. reconcile bank statements;
- 5. compare the advantages and disadvantages of different types of banking services;
- 6. examine investment growth by developing a personal investment plan; and
- 7. prepare an individual income tax return.
- K. The student explains the importance of marketing as well as the functions of marketing. The student is expected to:
 - 1. define marketing;
 - 2. understand how marketing is related to other functions of business;
 - 3. explain the marketing concept; and
 - 4. describe marketing functions and its related activities.

L. The student understands the scope of market identification. The student is expected to:

- 1. explain the concept of market and market identification;
- 2. identify market segments;
- 3. explain the difference between market segmentation and mass marketing;
- 4. define and explain the importance of target markets; and
- 5. identify a target market for a product or service using market segmentation.

M. The student understands the importance of an effective marketing mix. The student is expected to:

- 1. explain the concept of marketing strategies;
- 2. define each component of the marketing mix;
- 3. identify examples of an effective marketing mix;
- 4. create an effective marketing mix for a product or service; and
- 5. explain the role of participation as a key element of marketing.
- N. The student identifies career opportunities within the Business Management and Administration career cluster, the Marketing career cluster, and the Marketing career cluster and formulates a career plan. The student is expected to:
 - 1. analyze individual goals and interests;
 - 2. determine individual talents, abilities, and skills; and
 - 3. develop an individual career plan.

O. The student develops technology skills. The student is expected to:

- 1. use technology as a tool to research, organize, evaluate, and communicate information.
- 2. use digital technologies (computers, PDAs, media players, GPSs, etc.), communication/networking tools, and social networks appropriately to access, manage, integrate, evaluate, and create information to successfully function in a knowledge economy.
- 3. demonstrate utilizing current and new technologies specific to the program of study, course, and/or industry; and



4. apply a fundamental understanding of the ethical/legal issues surrounding the access and use of information technologies.



Entrepreneurship

 General requirements. This course is recommended for students in Grades 10-12. Recommended prerequisite: Principles of Business, Marketing, and Finance or Business Management. Students shall be awarded one credit for successful completion of this course.

2. Introduction.

- A. Career and technical education instruction provides content aligned with challenging academic standards and relevant technical knowledge and skills for students to further their education and succeed in current or emerging professions.
- B. The Marketing Career Cluster focuses on planning, managing, and performing marketing activities to reach organizational objectives.
- C. In Entrepreneurship, students will gain the knowledge and skills needed to become an entrepreneur. Students will learn the principles necessary to begin and operate a business. The primary focus of the course is to help students understand the process of analyzing a business opportunity, preparing a business plan, determining feasibility of an idea using research, and developing a plan to organize and promote the business and its products and services. In addition, students will understand the capital required, the return on investment desired, and the potential for profit.
- D. If taken as a Level II Course, students will participate in at least two Career Awareness Work-Based Learning experiences in this course, which might include informational interviews or job shadowing relevant to the program of study. If taken as a Level II Course, Students will participate in a Career Preparation Work-Based Learning experience in this course, which might include paid or unpaid internship experiences relevant to the program of study.
- E. Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations.

3. Knowledge and skills.

- A. The student demonstrates professional standards/employability skills as required by business and industry. The student is expected to:
 - 1. communicate effectively with others using speaking, listening, and writing skills;
 - 2. demonstrate collaboration skills through teamwork;
 - 3. demonstrate professionalism by conducting oneself in a manner appropriate for the profession and workplace;
 - 4. demonstrate a positive, productive work ethic by performing assigned tasks as directed;
 - 5. demonstrate integrity by choosing the ethical course of action and complying with all applicable rules, laws, and regulations;
 - 6. demonstrate time-management skills such as prioritizing tasks, following schedules, and tending to goalrelevant activities in ways that use time wisely and optimize efficiency and results; and
 - 7. demonstrate leadership skills by participating in career and technical student organizations.



- B. The student demonstrates an understanding of Design Thinking and applies the methodology as a strategy for innovation. The student is expected to:
 - 1. define the five-stage Design Thinking model proposed by the Hasso-Plattner Institute of Design at Stanford, including Empathize, Define, Ideate, Prototype, and Test.
 - 2. apply the Design Thinking model to a student-driven business opportunity, and present to an authentic audience.
- C. The student demonstrates an understanding of entrepreneurship and the entrepreneurial way of life. The student is expected to:
 - 1. clarify the terms entrepreneurship and entrepreneur;
 - 2. define small business; and
 - 3. analyze the advantages and disadvantages of entrepreneurship.
- D. The student visits local businesses and franchises to investigate business opportunities. The student is expected to:
 - 1. identify and analyze the four functions of a small business; and
 - 2. evaluate the issues involved with starting, taking over, or expanding an existing small business.

E. The student identifies the importance of a well-written business plan. The student is expected to:

- 1. identify the need for and the characteristics of a well-orchestrated business plan;
- 2. research business plan outlines, resources, and templates; and
- 3. create and present a well-orchestrated business plan and critically explain the contents.

F. The student explains the goal of a business and its unique proposition. The student is expected to:

- 1. describe the nature of a business and list the marketplace needs that it satisfies;
- 2. explain how a business's products and services meet the needs of the market;
- 3. list the specific consumers, organizations, or businesses that a company targets or will target;
- 4. explain the competitive advantages that make a business successful; and
- 5. create a well-orchestrated company description.
- G. The student explains and demonstrates how to meet the needs of a growing organization. The student is expected to:
 - 1. describe the role of operations and organization in a growing business; and
 - 2. create an organizational chart that defines the structure of a company.
- H. The student explains investment and financial resources to achieve business goals and objectives. The student is expected to:
 - 1. determine the financial plan, including financial requirements and sources of financing;
 - 2. explain the idea of a growth strategy, including horizontal and vertical growth strategies; and
 - 3. explain the idea of an exit strategy, including selling a business, going public, and liquidating a business.
- I. The student demonstrates and explains financial and accounting terms and forms. The student is expected to:
 - 1. explain and define basic accounting functions, terms, assets, and types of assets, including cash; accounts receivable; fixed, liquid, and illiquid assets; and inventory goods on hand;
 - 2. identify liabilities and types of liabilities such as accounts payable, long-term debt, and short-term debt;
 - 3. calculate owner's equity or net worth;



- 4. evaluate a balance sheet understanding the balance sheet equation (A = L + OE);
- 5. analyze profit and loss statements;
- 6. evaluate revenues and types of revenues;
- 7. determine expenses and types of expenses;
- 8. analyze alternative accounting and internal accounting controls;
- 9. discuss the importance of budgeting and cash flow;
- 10. use common accounting forms to demonstrate an understanding of their functions and results;
- 11. analyze the impact of specialization and division of labor on productivity;
- 12. explain the impact of the law of diminishing returns; and
- 13. create projected financial statements.
- J. The student knows the effects of credit on price and profit. The student is expected to:
 - 1. identify types of consumer credit;
 - 2. recommend types of consumer credit a business might offer;
 - 3. explain the risks and benefits to entrepreneurs when accepting and extending credit; and
 - 4. describe how credit affects profit and the negotiated price.
- K. The student understands the importance of product management and how it meets the needs of the customer. The student is expected to:
 - 1. explain product management;
 - 2. describe supply chain management; and
 - 3. create product-mix strategies, including branding elements and extended product features, to meet customer needs.
- L. The student knows that pricing has policies, objectives, and strategies. The student is expected to:
 - 1. develop and analyze pricing objectives;
 - 2. compare and contrast pricing policies for an entrepreneurial venture; and
 - 3. recommend appropriate pricing strategies.
- M. The student knows the importance of managing the pricing structure. The student is expected to:
 - 1. communicate the differences among pricing structures for goods, services, and ideas;
 - 2. develop a pricing structure for an entrepreneurial venture; and
 - 3. demonstrate how to calculate prices, markups, and discounts.
- N. The student knows elements and processes of product planning. The student is expected to:
 - 1. explain the nature and scope of product planning;
 - 2. define the term product mix; and
 - 3. identify stages of the product life cycle for business products.
- O. The student knows the process for development, implementation, and evaluation of a marketing plan. The student is expected to:
 - 1. explain how market penetration strategies contribute to successful marketing;
 - 2. apply evaluation strategies to determine the effectiveness of market penetration strategies;
 - 3. illustrate the concept of promotional mix;
 - 4. use appropriate technology to create promotional materials;
 - 5. apply evaluation strategies to determine promotional campaign effectiveness;



- 6. describe the development of a sales force; and
- 7. apply evaluation strategies to determine the effectiveness of sales activities.
- P. The student knows that purchasing usually occurs in a continuous cycle. The student is expected to:
 - 1. demonstrate the process of selecting suppliers and sources; and
 - 2. analyze and discuss selection of goods and services based on operational needs.
- Q. The student knows that entrepreneurial risk is the possibility of loss or failure. The student is expected to:
 - 1. categorize business risks such as human, natural, and economic;
 - 2. classify business risks as pure or speculative, controllable or uncontrollable, and insurable or uninsurable;
 - 3. explain security precautions and health, safety, and worker welfare regulations; and
 - 4. analyze examples of business risks to recommend and defend risk-management strategies.
- R. The student understands the importance of a business's social responsibility to society as it relates to shareholders, employees, customers, the community, and the environment. The student is expected to discuss the responsibility of business.
- S. The student understands business ethics and legal responsibilities. The student is expected to:
 - 1. explain ethical actions in business operations, including ethical considerations in providing information, confidential information, and information appropriate to obtain from a client or another employee; and
 - 2. manage internal and external business relationships to foster positive interactions by explaining the nature of human resources and workplace regulations, discussing employment relationships, and analyzing the impact of ethical decisions.
- T. The student acquires foundational knowledge of business laws and regulations to understand their nature and scope. The student is expected to:
 - 1. identify the legal issues affecting businesses; and
 - 2. investigate the impact of the legal issues.
- U. The student explains the civil foundations of the legal environment of business to demonstrate knowledge of contracts. The student is expected to:
 - 1. identify the basic torts relating to business enterprises; and
 - 2. describe the nature of legally binding contracts.
- V. The student explores the regulatory environment of business to understand the diversity of regulations. The student is expected to:
 - 1. describe the nature of legal procedure;
 - 2. discuss the nature of debtor-creditor relationships;
 - 3. explain the nature of agency relationships;
 - 4. discuss the nature of environmental law;
 - 5. identify the role of administrative law; and
 - 6. identify regulatory requirements affecting a business.

W. The student knows the scope and nature of distribution. The student is expected to:

Advertising

 General requirements. This course is recommended for students in Grades 9-12. Recommended prerequisite: Principles of Business, Marketing, and Finance. Students shall be awarded one-half credit for successful completion of this course.

Students will gain knowledge of techniques used in current advertising, including print, broadcast, and digital media. The course explores the social, cultural, ethical, and legal issues of advertising, historical influences, strategies, media decision processes as well as integrated marketing communications, and careers in advertising and sales promotion. The course provides an overview of how communication tools can be used to reach target audiences and increase consumer knowledge.
- D. Students will participate in a Career Preparation Work-Based Learning experience in this course, which might include paid or unpaid internship experiences relevant to the program of study.
- E. Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations.

 - 2. identify businesses related to advertising and sales.
- 1. The student develops and delivers presentations using appropriate media to engage and inform audiences. The student is expected to:
 - 1. prepare oral presentations to provide information for specific purposes and audiences;
 - 2. identify and prepare support materials that will enhance an oral presentation; and
 - 3. deliver an oral presentation that sustains listener attention and interest.

 - 2. distinguish between the four components of marketing, including paid, earned, shared, and owned (PESO).

P. The student develops technology skills. The student is expected to:

Fashion Marketing

- D. Students will participate in a Career Preparation Work-Based Learning experience in this course, which might include paid or unpaid internship experiences relevant to the program of study.
- E. Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations.

3. Knowledge and skills.

 - 4. position products and services to acquire a desired business image.

- D. Students will participate in a Career Preparation Work-Based Learning experience in this course, which might include paid or unpaid internship experiences relevant to the program of study.
- E. Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations.

 - 1. evaluate and understand how social media has influenced the function of marketing;
 - 2. evaluate and understand how social media has evolved and influenced the way people communicate;
 - 3. analyze and evaluate the influence of social media on individuals and how individuals influence social media; and
 - 4. identify potential risks, advantages, and limitations of digital marketing tools.
- E. The student knows that strategic planning is essential to the success of social media marketing. The student is expected to:
 - 1. define the social media marketing process;
 - 2. understand participation as a key element of the marketing mix;
 - 3. understand how to integrate social media marketing into the Integrated Marketing Plan to promote brand/company awareness; and
 - 4. develop a social media marketing plan.

- 2. analyze data used to make accurate forecasts and informed business decisions.

G. The student knows pricing strategies. The student is expected to:

- 1. compare and contrast pricing strategies; and
- 2. analyze the price of sports and entertainment marketing products.
- H. The student knows the elements and processes of product planning. The student is expected to:
 - 1. describe stages of new-product planning;
 - 2. illustrate the product mix; and
 - 3. identify stages of the product life cycle for new or existing sports or entertainment marketing products.

- 7. explain the concept of competition for discretionary income.

- 1. identify components and content for a sponsorship proposal;
- 2. define and explain sponsorship issues;
- 3. categorize costs associated with a sponsorship;



- 4. identify types of sponsorship sales and relationship development;
- 5. examine benefits of sponsorship opportunities; and
- 6. explain laws that may affect a sponsorship agreement.

R. The student has an understanding of endorsement contracts. The student is expected to:

- 1. identify components of endorsement contracts;
- 2. discuss issues related to celebrity behavior on endorsements; and
- 3. research the rationale for a business to engage in endorsement contracts.

S. The student understands the importance of branding. The student is expected to:

- 1. define branding;
- 2. differentiate between types of brands;
- 3. identify examples of brand equity and brand extension in sports and entertainment;
- 4. explain the value in building a strong brand; and
- 5. determine the characteristics of a successful brand.

T. The student understands the importance of licensing. The student is expected to:

- 1. define licensing;
- 2. distinguish between licensor and licensee;
- 3. explain the advantages and disadvantages of licensing; and
- 4. identify examples of licensing in sports and entertainment.

U. The student knows the effect the fan experience has on the success of a sports business. The student is expected to:

- 1. explain how promoting and implementing a positive fan experience impacts revenues;
- 2. describe situations that impact the fan experience;
- 3. describe the concept of the fan/spectator experience;
- 4. define the term game operations;
- 5. explain the role of game entertainment in the sports business;
- 6. define game attractiveness;
- 7. identify game involvement activities that enhance fan experience; and
- 8. create a game operations plan to increase game attractiveness.

V. The student understands the importance of effectively communicating information with customers, media, and fans. The student is expected to:

- 1. explain why communications in sports and entertainment are important;
- 2. understand issues that impact the business of sports and entertainment;
- 3. define media;
- 4. understand the importance of media rights;
- 5. define publicity;
- 6. differentiate between publicity, public relations, media relations, and community relations;
- 7. create a press release;
- 8. create a press kit; and
- 9. simulate a press conference.



W. The student understands the strategies of successful entertainment marketing. The student is expected to:

- 1. discuss the different kinds of entertainment distribution;
- 2. identify strategies to market entertainment products; and
- 3. explain the promotional value of entertainment awards.

X. The student develops technology skills. The student is expected to:

- 1. use technology as a tool to research, organize, evaluate, and communicate information.
- 2. use digital technologies (computers, PDAs, media players, GPSs, etc.), communication/networking tools, and social networks appropriately to access, manage, integrate, evaluate, and create information to successfully function in a knowledge economy.
- 3. demonstrate utilizing current and new technologies specific to the program of study, course, and/or industry; and
- 4. apply a fundamental understanding of the ethical/legal issues surrounding the access and use of information technologies.



Practicum in Marketing

 General requirements. This course is recommended for students in Grade 12. The practicum course is a paid or unpaid capstone experience for students participating in a coherent sequence of career and technical education courses in the Marketing Career Cluster. Prerequisites include any two of the following Level II courses: Advertising, Fashion Marketing, Social Media Marketing, or Sports and Entertainment Marketing. Students shall be awarded one credits for successful completion of this course.

2. Introduction.

- A. Career and technical education instruction provides content aligned with challenging academic standards and relevant technical knowledge and skills for students to further their education and succeed in current or emerging professions.
- B. The Marketing Career Cluster focuses on planning, managing, and performing marketing activities to reach organizational objectives.
- C. Practicum in Marketing is a series of dynamic activities that focus on the customer to generate a profitable exchange. Students will gain knowledge and skills that help them to be proficient in one or more of the marketing functional areas associated with distribution, financing, marketing information management, pricing, product planning, promotion, purchasing, risk management, and selling skills. Students will integrate skills from academic subjects, information technology, interpersonal communication, and management training to make responsible decisions. The practicum course is a paid or unpaid experience for students participating in a coherent sequence of career and technical courses in marketing.
- D. Students will participate in a Career Preparation Work-Based Learning experience in this course, which includes paid or unpaid internship, pre-apprenticeship, or apprenticeship experiences relevant to the program of study.
- E. Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations.

3. Knowledge and skills.

- A. The student demonstrates professional standards/employability skills as required by business and industry. The student is expected to:
 - 1. communicate effectively with others using speaking, listening, and writing skills;
 - 2. demonstrate collaboration skills through teamwork;
 - 3. demonstrate professionalism by conducting oneself in a manner appropriate for the profession and workplace;
 - 4. demonstrate a positive, productive work ethic by performing assigned tasks as directed;
 - 5. demonstrate integrity by choosing the ethical course of action and complying with all applicable rules, laws, and regulations;
 - 6. demonstrate time-management skills such as prioritizing tasks, following schedules, and tending to goalrelevant activities in ways that use time wisely and optimize efficiency and results; and
 - 7. demonstrate leadership skills by participating in activities such as career and technical education student organizations.



B. The student knows the nature of business and shows its contribution to society. The student is expected to:

- 1. distinguish ways that businesses contribute to society;
- 2. explain the importance of social responsibility;
- 3. describe types of business activities;
- 4. explain the organizational design of businesses;
- 5. discuss the global environment in which businesses operate; and
- 6. depict factors that affect the business environment and how businesses can respond.

C. The student demonstrates the importance of marketing and the functions of marketing. The student is expected to:

- 1. explain the marketing concept; and
- 2. describe each marketing function and how it relates to the marketing concept.
- D. The student analyzes the marketing mix, which involves a combination of the decisions about product, price, place, promotion, and people. The student is expected to:
 - 1. explain how each component of the marketing mix contributes to successful marketing; and
 - 2. illustrate the importance of marketing strategies in the marketing mix.
- E. The student knows the concepts and strategies used to determine target markets and market identification. The student is expected to:
 - 1. explain the importance of target markets;
 - 2. compare and contrast advantages and disadvantages of market segmentation and mass marketing;
 - 3. distinguish among geographic, demographic, psychographic, and behavioral segmentation; and
 - 4. explain the nature of marketing planning.

F. The student applies mathematical concepts in marketing. The student is expected to:

- 1. execute calculations involving money, time, space, materials, and data;
- 2. interpret charts and graphs to make informed marketing decisions;
- 3. use formulas and equations to determine price, profit, costs, and break-even point;
- 4. perform mathematical operations;
- 5. predict reasonable estimations;
- 6. create mathematical models from real-life situations; and
- 7. determine rate of change mathematically.

G. The student knows how to use self-development techniques and interpersonal skills to accomplish marketing objectives. The student is expected to:

- 1. identify and practice effective interpersonal and team-building skills involving situations with coworkers, managers, and customers;
- 2. develop short- and long-term personal goals;
- 3. identify and use time-management principles; and
- 4. participate in leadership and career development activities.

H. The student applies information technology as an effective marketing tool. The student is expected to:

- 1. identify social media trends in marketing;
- 2. identify ways that technology impacts business;
- 3. apply web-search skills;



- 4. demonstrate word-processing skills;
- 5. use database applications; and
- 6. execute spreadsheet applications.
- 1. The student recognizes that careers are ever changing and require continual self-assessment, research, and preparation to develop and implement responsible decisions. The student is expected to:
 - 1. develop a working portfolio containing components such as resume, cover letter, thank you letter, references, letter of recommendation, and work samples;
 - 2. analyze personal social media accounts for potential employability; and
 - 3. demonstrate interview skills.
- J. The student knows the importance of emerging trends and technologies in marketing. The student is expected to:
 - 1. discuss trends affecting marketing; and
 - 2. research emerging technologies in marketing.
- K. The student knows the impact and value of diversity. The student is expected to:
 - 1. explain how diversity affects marketing; and
 - 2. probe the impact of multiculturalism and multigenerationalism on marketing activities.
- L. The student knows that marketing begins with a working knowledge of economic concepts. The student is expected to:
 - 1. discuss characteristics of economic goods and services;
 - 2. identify economic needs and wants;
 - 3. explain the concept of utility and cite examples of types of utility;
 - 4. describe the function of prices in markets; and
 - 5. clarify how the interaction of supply and demand affects price.
- M. The student knows that a nation's economic system is determined by what is produced, how it is produced, and how it is distributed. The student is expected to:
 - 1. compare and contrast how economies answer basic economic questions;
 - 2. explain why most economies are mixed; and
 - 3. determine the relationship between government and business.
- N. The student knows that private enterprise is based on independent decisions by businesses and limited government involvement. The student is expected to:
 - 1. determine characteristics of a private enterprise system;
 - 2. explain the advantages and disadvantages of private enterprise; and
 - 3. identify examples of competitive business situations such as price or nonprice competition.
- O. The student knows that economic factors such as gross domestic product, standard of living, consumer price index, and unemployment figures help influence a company's marketing strategies. The student is expected to:
 - 1. identify economic measurements used to analyze an economy;
 - 2. research how economic measures are used in a market economy;
 - 3. describe the concept of price stability as an economic measure;
 - 4. interpret the measure of consumer spending as an economic indicator;



- 5. examine the impact of a nation's unemployment rates; and
- 6. describe the economic impact of inflation on business.
- P. The student knows that changes in the economy include prosperity, recession, depression, and recovery and are collectively referred to as the business cycle. The student is expected to:
 - 1. explain the concept of business cycles; and
 - 2. describe the impact that phases of a business cycle have on the economy.
- Q. The student knows that distribution systems facilitate the movement of products. The student is expected to:
 - 1. understand channels of distribution;
 - 2. identify physical distribution activities; and
 - 3. examine costs associated with distribution.
- R. The student knows that marketers use investment and financial services to achieve goals and objectives. The student is expected to:
 - 1. illustrate types of financial services; and
 - 2. explain the purpose of a credit contract.
- S. The student knows the concept of pricing and strategies used in determining and adjusting price. The student is expected to:
 - 1. state goals of pricing;
 - 2. identify factors affecting pricing;
 - 3. explain how pricing affects product, place, and promotion decisions;
 - 4. compare and contrast pricing policies;
 - 5. calculate a product's price;
 - 6. describe the role of business ethics in pricing; and
 - 7. analyze legal considerations for pricing.
- T. The student understands the promotional concepts and strategies needed to communicate information about products, services, images, and ideas to achieve a desired outcome. The student is expected to:
 - 1. explain the communication processes as used in promotional activities;
 - 2. evaluate types of promotion;
 - 3. understand the concept of promotional mix;
 - 4. define the role of promotion as a marketing function;
 - 5. describe the use of business ethics in promotion;
 - 6. explore the regulation of promotion;
 - 7. explain the nature of direct marketing channels;
 - 8. model communication channels used in sales promotion; and
 - 9. describe communication channels used in public relations activities.
- U. The student knows that advertising is the paid form of nonpersonal communication about an identified sponsor's products. The student is expected to:
 - 1. illustrate types of advertising media;
 - 2. differentiate between product and institutional advertising; and
 - 3. identify and evaluate elements of an advertisement.



- V. The student knows that business risk is the possibility of loss or failure. The student is expected to:
 - 1. categorize business risks; and
 - 2. interpret how various types of risks impact business activities.
- W. The student knows that marketers responsible for risk management follow a process to decide the best strategy to deal with each risk. The student is expected to:
 - 1. evaluate security precautions; and
 - 2. demonstrate knowledge of safety precautions in the workplace.
- X. The student knows what influences customers before they make a purchase. The student is expected to:
 - 1. differentiate among a feature and a benefit;
 - 2. compare and contrast between consumer and organizational buying behavior;
 - 3. determine customer needs and wants;
 - 4. classify buying motives; and
 - 5. analyze how customers and organizations apply the decision-making process.
- Y. The student knows how marketers use the selling process. The student is expected to:
 - 1. locate product information; and
 - 2. illustrate the sale process.
- Z. The student understands the techniques and strategies used to foster positive, ongoing relationships with customers to enhance company image. The student is expected to:
 - 1. explain the nature of positive customer relations;
 - 2. describe a customer service mindset;
 - 3. explain the management role in customer relations;
 - 4. identify a company brand promise;
 - 5. explore ways of reinforcing company image through employee performance; and
 - 6. describe the use of technology in customer relationship management.

AA. The student understands a business's responsibility to know and abide by workplace laws, trade regulations, and ethical behavior that affect business operations. The student is expected to:

- 1. apply ethics to demonstrate trustworthiness;
- 2. explain the nature of business ethics;
- 3. describe legal issues affecting businesses;
- 4. defend the nature of human resources regulations;
- 5. explain the nature of workplace regulations such as Occupational Safety and Health Administration and statutes such as the Americans with Disabilities Act;
- 6. discuss employment relationships;
- 7. illustrate the nature of trade regulations; and
- 8. describe the impact of antitrust legislation.
- BB. The student applies ethical reasoning to a variety of workplace situations in order to make ethical decisions. The student is expected to:
 - 1. evaluate alternative responses to workplace situations based on personal or professional ethical responsibilities;
 - 2. identify personal and long-term workplace consequences of unethical or illegal behaviors;



- 3. investigate the most appropriate response to workplace situations based on legal and ethical considerations; and
- 4. demonstrate responsible behavior, honesty, integrity, and ethical work habits.
- CC. The student completes required training, education, and certification to prepare for employment in a particular career field. The student is expected to:
 - 1. identify training, education, and certification requirements for occupational choice; and
 - 2. participate in career-related training or degree programs.

DD. The student knows the elements and processes of product planning. The student is expected to:

- 1. explain the nature and scope of product planning;
- 2. relate product-mix strategies to meet customer expectations; and
- 3. define the product life cycle.

EE. The student develops technology skills. The student is expected to:

- 1. use technology as a tool to research, organize, evaluate, and communicate information.
- 2. use digital technologies (computers, PDAs, media players, GPSs, etc.), communication/networking tools, and social networks appropriately to access, manage, integrate, evaluate, and create information to successfully function in a knowledge economy.
- 3. demonstrate utilizing current and new technologies specific to the program of study, course, and/or industry; and
- 4. apply a fundamental understanding of the ethical/legal issues surrounding the access and use of information technologies.
